1. ON OCTOBER 17, 2007, THE DEPARTMENT OF COMMERCE (COMMERCE) INACTIVATED THE SCREEN IN THE AD/CVD MODULE FOR TOTTORI YAMAKAI BEARINGS SEISAKUSHO LTD. (TOTTORI YAMAKAI)(A-588-201-013).

2. TOTTORI YAMAKAI PARTICIPATED IN PAST ADMINISTRATIVE REVIEWS OF THE ANTIDUMPING DUTY ORDER ON BALL BEARINGS AND PARTS THEREOF FROM JAPAN. IN THE 1998/1999 ADMINISTRATIVE REVIEW OF THE ORDER, COMMERCE REFERRED TO THE COMPANY AS TOTTORI YAMAKAI AND ITS TRADE NAME, KYK CORPORATION LTD. (KYK) (A-588-201-040),

INTERCHANGEABLY. ON SEPTEMBER 18, 2006, COUNSEL FOR KYK INFORMED COMMERCE THAT TOTTORI YAMAKAI HAD ENTERED INTO BANKRUPTCY IN 2000 AND HAD EMERGED FROM BANKRUPTCY IN 2002. COUNSEL STATED THAT, SINCE EMERGING FROM BANKRUPTCY, ITS CLIENT NO LONGER USES THE NAME OF TOTTORI YAMAKAI. THUS, COMMERCE INACTIVATED THE SCREEN IN THE MODULE FOR TOTTORI YAMAKAI ON OCTOBER 17, 2007. THE SCREEN FOR KYK (A-588-201-040) REMAINS ACTIVE.

3. AS A RESULT OF COMMERCE'S DETERMINATION, CUSTOMS AND BORDER PROTECTION (CBP) IS INSTRUCTED TO NOT PERMIT ENTRIES OF BALL BEARINGS AND PARTS THEREOF FROM JAPAN TO BE ENTERED OR WITHDRAWN

FROM WAREHOUSE FOR CONSUMPTION UNDER CASE NUMBER A-588-201-013 ON OR AFTER 10/17/2007. FOR ALL ENTRIES OF BALL BEARINGS AND PARTS THEREOF MADE UNDER CASE NUMBER A-588-201-013 PRIOR TO 04/30/2007, LIQUIDATION INSTRUCTIONS HAVE BEEN ISSUED. FOR ANY ENTRIES MADE UNDER THIS NUMBER BETWEEN 05/01/2007 AND 10/17/2007, LIQUIDATION INSTRUCTIONS WILL BE ISSUED AFTER THE CLOSE OF THE NEXT ANNIVERSARY MONTH (MAY 2008).
