THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (72 FR 68123) ON 12/04/2007 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF A CERTAIN MANUFACTURER/EXPORTER SUBJECT TO THE ANTIDUMPING DUTY ORDER ON STAINLESS STEEL WIRE RODS FROM INDIA FOR THE PERIOD 12/01/2005 THROUGH 11/30/2006.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATE HAS BEEN REVISED FOR A CERTAIN MANUFACTURER/EXPORTER. THEREFORE, FOR SHIPMENTS OF STAINLESS STEEL WIRE RODS FROM INDIA ENTERED OR

WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION ON OR AFTER 12/04/2007,  
THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING

FURTHER NOTICE. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE  
INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL ASSESSMENT  
INSTRUCTIONS ARE RECEIVED.
