1. THE DEPARTMENT OF COMMERCE HAS REVOKED THE ANTIDUMPING DUTY ORDER ON BALL BEARINGS AND PARTS THEREOF FROM THE UNITED KINGDOM IN PART AND PUBLISHED THE REVOCATION IN THE FEDERAL REGISTER ON 07/12/2001. THE PARTIAL REVOCATION APPLIES TO ALL SUBJECT MERCHANDISE PRODUCED AND SOLD BY SNFA U.K. AND THE EFFECTIVE DATE OF THE REVOCATION IS 05/01/2000.

2. THEREFORE, CUSTOMS AND BORDER PROTECTION (CBP) IS DIRECTED TO TERMINATE THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF

BALL BEARINGS AND PARTS THEREOF PRODUCED AND SOLD BY (AS INDICATED ON THE COMMERCIAL INVOICE OR CUSTOMS DOCUMENTATION) SNFA U.K. ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 05/01/2000.

3. ENTRIES ON OR AFTER 5/1/2000 WERE ADDRESSED IN LIQUIDATION MESSAGE NUMBERS 3017201 (1/17/2003), 2071204 (3/12/2002), 2253202 (9/10/2002), 3210203 (7/29/2003), 4232203 (8/19/2004), 5216201 (8/4/2005), 6199215 (7/18/2006), AND 7184212 (7/3/2007).

4. FOR ANY ENTRIES OF SUBJECT MERCHANDISE PRODUCED AND SOLD BY SNFA U.K. ENTERED OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION ON OR AFTER 05/01/2000 WHICH REMAIN SUSPENDED CBP IS DIRECTED TO TERMINATE THE SUSPENSION AND LIQUIDATE WITHOUT REGARD TO ANTIDUMPING DUTIES (I.E., RELEASE ALL BONDS AND REFUND ALL CASH DEPOSITS).

5. NOTICE OF THE LIFTING OF SUSPENSION OF LIQUIDATION OF ENTRIES OF BALL BEARINGS AND PARTS THEREOF PRODUCED AND SOLD BY (AS INDICATED ON THE COMMERCIAL INVOICE OR CUSTOMS DOCUMENTATION) SNFA U.K. ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 05/01/2000 OCCURRED WITH THE PUBLICATION OF THE FINAL RESULTS OF ADMINISTRATIVE REVIEW (66 FR 36551 (JULY 12, 2001)).

6. THE ASSESSMENT OF ANTIDUMPING DUTIES BY U.S. CUSTOMS AND BORDER PROTECTION (CBP) ON ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CBP PAY INTEREST ON OVERPAYMENTS AND ASSESS INTEREST ON UNDERPAYMENTS OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER WHICH IS MAY 15, 1989. INTEREST SHALL BE CALCULATED FROM THE DATE PAYMENT OF ESTIMATED ANTIDUMPING DUTIES IS REQUIRED THROUGH THE DATE OF LIQUIDATION.

THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.
