1. AS A RESULT OF A FIVE-YEAR ("SUNSET") REVIEW, THE U.S.
DEPARTMENT OF COMMERCE (COMMERCE) HAS REVOKED THE ANTIDUMPING
DUTY ORDER ON CERTAIN HOT-ROLLED CARBON STEEL FLAT PRODUCTS FROM
ARGENTINA (A-357-814). THIS REVOCATION WAS PUBLISHED IN THE
FEDERAL REGISTER ON 11/20/2007 (72 FR 65293). THE EFFECTIVE DATE
OF THE REVOCATION IS 09/19/2006.

2. U.S. CUSTOMS AND BORDER PROTECTION (CBP) IS DIRECTED TO TERMINATE THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF CERTAIN HOT-ROLLED CARBON STEEL FLAT PRODUCTS FROM ARGENTINA, ENTERED OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION, ON OR AFTER

09/19/2006. ALL ENTRIES OF THE SUBJECT MERCHANDISE THAT WERE SUSPENDED ON OR AFTER 09/19/2006 SHOULD BE LIQUIDATED WITHOUT REGARD TO ANTIDUMPING DUTIES (I.E., RELEASE ALL BONDS AND REFUND ALL CASH DEPOSITS, WITH INTEREST).

3. LIQUIDATION INSTRUCTIONS COVERING ENTRIES OF CERTAIN HOT-ROLLED CARBON STEEL FLAT PRODUCTS FROM ARGENTINA DURING THE PERIOD 09/01/2006 THROUGH 08/31/2007 WERE PREVIOUSLY ISSUED UNDER NOVEMBER 2007 AUTOMATIC LIQUIDATION INSTRUCTIONS.

4. NOTICE OF THE LIFTING OF SUSPENSION OF LIQUIDATION OF ENTRIES OF SUBJECT MERCHANDISE ENTERED OR WITHDRAWN FROM WAREHOUSE ON OR AFTER 09/19/2006 OCCURRED WITH THE PUBLICATION OF THE NOTICE OF SUNSET REVOCATION IN THE FEDERAL REGISTER (72 FR 65293, 11/20/2007).

5. THE ASSESSMENT OF ANTIDUMPING DUTIES BY CBP ON ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CBP PAY INTEREST ON OVERPAYMENTS OR ASSESS INTEREST ON UNDERPAYMENTS, OF

THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE OF PAYMENT OF ESTIMATED ANTIDUMPING DUTIES THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.
