1. THE DEPARTMENT OF COMMERCE HAS REVOKED THE ANTIDUMPING DUTY ORDER ON CERTAIN STEEL CONCRETE REINFORCING BARS FROM TURKEY IN PART AND PUBLISHED THE REVOCATION IN THE FEDERAL REGISTER ON 11/06/2007 (72 FR 62630). THE PARTIAL REVOCATION APPLIES TO ALL SUBJECT MERCHANDISE PRODUCED AND EXPORTED BY DILER DEMIR CELIK ENDUSTRISI VE TICARET A.S. OR YAZICI DEMIR CELIK SANAYI VE TURIZM TICARET A.S. AND EXPORTED BY DILER DEMIR CELIK ENDUSTRISI VE TICARET A.S., YAZICI DEMIR CELIK SANAYI VE TURIZM TICARET

A.S., OR DILER DIS TICARET A.S. AND THE EFFECTIVE DATE OF THE REVOCATION IS 04/01/2006.

2. THEREFORE, CBP IS DIRECTED TO TERMINATE THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF CERTAIN STEEL CONCRETE REINFORCING BARS PRODUCED AND EXPORTED BY DILER DEMIR CELIK ENDUSTRISI VE TICARET A.S. OR YAZICI DEMIR CELIK SANAYI VE TURIZM TICARET A.S. AND EXPORTED BY DILER DEMIR CELIK ENDUSTRISI VE TICARET A.S., YAZICI DEMIR CELIK SANAYI VE TURIZM TICARET A.S., OR DILER DIS TICARET A.S. ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 04/01/2006. ALL ENTRIES OF CERTAIN STEEL CONCRETE REINFORCING BARS PRODUCED AND EXPORTED

BY DILER DEMIR CELIK ENDUSTRISI VE TICARET A.S. OR YAZICI DEMIR CELIK SANAYI VE TURIZM TICARET A.S. AND EXPORTED BY DILER DEMIR CELIK ENDUSTRISI VE TICARET A.S., YAZICI DEMIR CELIK SANAYI VE TURIZM TICARET A.S., OR DILER DIS TICARET A.S. THAT WERE SUSPENDED ON OR AFTER 04/01/2006 SHOULD BE LIQUIDATED WITHOUT REGARD TO ANTIDUMPING DUTIES (I.E., RELEASE ALL BONDS AND REFUND ALL CASH DEPOSITS).

3. NOTICE OF THE LIFTING OF SUSPENSION OF LIQUIDATION ON ENTRIES OF THE MERCHANDISE FOR THE PERIOD LISTED ABOVE OCCURRED WITH THE PUBLICATION OF THE REVOCATION IN THE FEDERAL REGISTER ON 11/06/2007 (72 FR 62630).

4. THE ASSESSMENT OF ANTIDUMPING DUTIES BY CUSTOMS AND BORDER PROTECTION ON ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CBP PAYS INTEREST ON OVERPAYMENTS AND ASSESS INTEREST ON UNDERPAYMENTS OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE OF PAYMENT OF ESTIMATED ANTIDUMPING DUTIES THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT

UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.
