2. THE DEPARTMENT OF COMMERCE DETERMINED THAT SIGNATURE'S CANDLES DO NOT QUALIFY FOR EXCLUSION FROM THE SCOPE OF THE ANTIDUMPING ORDER COVERING PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA PURSUANT TO THE NOVELTY CANDLE EXCEPTION.

3. EFFECTIVE 12/17/2007, CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA, INCLUDING SIGNATURE'S CANDLES LISTED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA.
