1. ON 11/06/2006, THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER 71 FR 64926 IN THE ANTIDUMPING DUTY REVIEW OF FRESHWATER CRAWFISH TAIL MEAT FROM THE PEOPLE'S REPUBLIC OF CHINA. THIS IS A CORRECTION OF PARAGRAPH 2 IN MESSAGE 7312202, DATED 11/08/2007 OF A-570-848, FOR THE PERIOD 03/26/1997 THROUGH 08/31/1998.

2. IN PARAGRAPH 2 OF MESSAGE 7312202, THE DEPARTMENT PROVIDED AN

INCORRECT ASSESSMENT RATE FOR FRESHWATER CRAWFISH TAIL MEAT FROM THE PEOPLE'S REPUBLIC OF CHINA EXPORTED BY HUAIYIN FOREIGN TRADE CORPORATION (5) ("HFTC5") FOR PERIOD 03/26/1997 THROUGH 08/31/1998.

3. PARAGRAPH 2 OF MESSAGE 7312202 CURRENTLY READS AS FOLLOWS:

FOR ALL SHIPMENTS OF FRESHWATER CRAWFISH TAIL MEAT FROM THE PEOPLE'S REPUBLIC OF CHINA EXPORTED BY HFTC5, AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 03/26/1997 THROUGH 08/31/1998, ASSESS AN ANTIDUMPING LIABILITY OF 2.16 PERCENT OF THE ENTERED VALUE.

INSTEAD, PARAGRAPH 2 OF MESSAGE NUMBER 7312202 SHOULD READ AS FOLLOWS:

FOR ALL SHIPMENTS OF FRESHWATER CRAWFISH TAIL MEAT FROM THE PEOPLE'S REPUBLIC OF CHINA EXPORTED BY HFTC5, AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 03/26/1997 THROUGH 08/31/1998, ASSESS AN ANTIDUMPING LIABILITY OF 201.63 PERCENT OF THE ENTERED VALUE.
