1. AS A RESULT OF A FIVE-YEAR ("SUNSET") REVIEW, THE U.S.
DEPARTMENT OF COMMERCE (COMMERCE) HAS REVOKED THE COUNTERVAILING

DUTY ORDER ON CERTAIN HOT-ROLLED CARBON STEEL FLAT PRODUCTS FROM

SOUTH AFRICA. THIS REVOCATION WAS PUBLISHED IN THE FEDERAL
REGISTER ON 11/20/2007 (72 FR 65293). THE EFFECTIVE DATE OF THE
REVOCATION IS 12/03/2006.

2. U.S. CUSTOMS AND BORDER PROTECTION (CBP) IS DIRECTED TO TERMINATE THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF CERTAIN HOT-ROLLED CARBON STEEL FLAT PRODUCTS FROM SOUTH AFRICA, ENTERED OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION ON OR AFTER

12/03/2006. ALL ENTRIES OF THE SUBJECT MERCHANDISE THAT WERE SUSPENDED ON OR AFTER 12/03/2006 SHOULD BE LIQUIDATED WITHOUT REGARD TO COUNTERVAILING DUTIES (I.E., RELEASE ALL BONDS AND REFUND ALL CASH DEPOSITS, WITH INTEREST).

3. ENTRIES OF THE SUBJECT PRODUCT ENTERED OR WITHDRAWN FROM WAREHOUSE PRIOR TO 12/03/2006 SHOULD NOT BE LIQUIDATED UNTIL YOU RECEIVE SEPARATE AND SPECIFIC INSTRUCTIONS.

4. NOTICE OF THE LIFTING OF SUSPENSION OF LIQUIDATION OF ENTRIES OF SUBJECT MERCHANDISE ENTERED OR WITHDRAWN FROM WAREHOUSE ON OR

AFTER 12/03/2006 OCCURRED WITH THE PUBLICATION OF THE NOTICE OF SUNSET REVOCATION IN THE FEDERAL REGISTER, 72 FR 65293, 11/20/2007.

5. THE ASSESSMENT OF COUNTERVAILING DUTIES BY CBP ON ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CBP PAY INTEREST ON OVERPAYMENTS OR ASSESS INTEREST ON UNDERPAYMENTS, OF

THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED COUNTERVAILING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED COUNTERVAILING DUTIES BEFORE THE DATE OF PUBLICATION OF THE COUNTERVAILING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE OF PAYMENT OF ESTIMATED COUNTERVAILING DUTIES THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.
