1. ON 1/31/2008 THE U.S. COURT OF INTERNATIONAL TRADE (CIT)
ISSUED A TEMPORARY RESTRAINING ORDER (TRO) ENJOINING LIQUIDATION
OF CERTAIN ENTRIES PRODUCED AND/OR EXPORTED BY SCHAEFFLER KG,
INA SCHAEFFLER KG, OR FAG KUGELFISCHER AG, WHICH ARE SUBJECT TO
THE ANTIDUMPING DUTY ORDER ON BALL BEARINGS AND PARTS THEREOF
FROM GERMANY (A-428-201-001, A-428-201-004, A-428-201-091) FOR
THE PERIOD 05/01/2006 THROUGH 04/30/2007.

2. THIS TRO WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 06-00334 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE. THIS TRO SHALL BE EFFECTIVE FOR ALL ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 5:00 P.M. ON THE FIFTH BUSINESS DAY AFTER JANUARY 31, 2008, THE DAY ON WHICH A COPY OF THE ORDER WAS SERVED BY HAND-DELIVERY ON THE APO DOCKET CENTER AT COMMERCE, AND SHALL REMAIN IN EFFECT UNTIL C.O.B. FEBRUARY 15, 2008.

3. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THIS TRO HAVE NOT YET BEEN ISSUED.

4. ACCORDINGLY, EFFECTIVE 2/7/2008 UNTIL C.O.B. 2/15/2008, CBP IS INSTRUCTED NOT TO LIQUIDATE ENTRIES OF MERCHANDISE SUBJECT TO THE TRO, AS DESCRIBED IN PARAGRAPH 1 OF THIS INSTRUCTION. ANY ENTRIES THAT ARE SET FOR LIQUIDATION MUST BE UNSET IMMEDIATELY. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES OF BALL BEARINGS AND PARTS THEREOF FROM GERMANY FOR THE PERIOD 05/01/2006 THROUGH 04/30/2007 FROM SCHAEFFLER KG, INA SCHAEFFLER KG, OR FAG KUGELFISCHER AG UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.
