2. PURSUANT TO THE SETTLEMENT AGREEMENT ON GRAY PORTLAND CEMENT

AND CLINKER FROM MEXICO, THE CASH-DEPOSIT PER-METRIC-TON AMOUNT

HAS BEEN REVISED EFFECTIVE 1/11/2008 FOR ENTRIES OF SUBJECT MERCHANDISE PRODUCED OR EXPORTED BY APASCO (A-201-802-002). THEREFORE, FOR SHIPMENTS OF CEMENT FROM MEXICO PRODUCED OR EXPORTED BY APASCO AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 01/11/2008, THE REQUIRED CASH DEPOSIT IS \$3.00 PER METRIC TON.

3. THESE CASH-DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL FURTHER NOTICE. DO NOT LIQUIDATE ANY ENTRIES OF CEMENT FROM MEXICO UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS.

4. FOR ALL MANUFACTURERS/EXPORTERS OF CEMENT FROM MEXICO WITHOUT THEIR OWN RATE, THE CASH-DEPOSIT RATE IS 61.85 PERCENT.
