THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER (72

FR 62834) ON 11/07/2007 THE SECOND AMENDED FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CERTAIN EXPORTERS SUBJECT TO THE ANTIDUMPING ORDER ON WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA FOR THE PERIOD 06/24/2004 THROUGH 12/31/2005.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN EXPORTERS. THEREFORE, FOR SHIPMENTS OF WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 11/07/2007, THE REQUIRED PERCENT CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING EXPORTERS:
