ON 03/13/2008, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A TEMPORARY RESTRAINING ORDER ENJOINING LIQUIDATION OF ENTRIES OF CONVERTIBLE INFANT CRIBS WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON WOODEN BEDROOM FURNITURE FROM THE PEOPLES REPUBLIC OF CHINA (A-570-890), IMPORTED BY AP INDUSTRIES INC. ON OR AFTER 06/24/2004.

2. THIS TEMPORARY RESTRAINING ORDER WAS ISSUED IN CONNECTION

WITH COURT CASE NUMBER 08-00090 AND RESTRAINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE UNLIQUIDATED ENTRIES OF CONVERTIBLE INFANT CRIBS WHICH WERE IMPORTED BY AP INDUSTRIES INC. ON OR AFTER 06/24/2004. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. LIQUIDATION INSTRUCTIONS FOR CERTAIN ENTRIES AFFECTED BY THIS TEMPORARY RESTRAINING ORDER HAVE BEEN ISSUED: SEE MESSAGE NUMBER 6205205 DATED 07/24/2006; MESSAGE NUMBER 7241204 DATED 08/29/2007; AND MESSAGE NUMBER 8024215 DATED 01/24/2008.

5. EFFECTIVE AS OF 3/13/2008, U.S. CUSTOMS AND BORDER PROTECTION IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY UNLIQUIDATED ENTRIES OF CONVERTIBLE INFANT CRIBS FROM THE PRC IMPORTED BY AP INDUSTRIES INC.

6. THE TEMPORARY RESTRAINING ORDER WAS ISSUED ON 03/13/2008. PURSUANT TO THE TERMS OF THE TEMPORARY RESTRAINING ORDER, NO LIQUIDATION OF THE ENTRIES COVERED BY THE TEMPORARY RESTRAINING ORDER MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AT THE TIME OF ISSUANCE OF THIS ORDER.
