2. ACCORDINGLY, YOU ARE NOW INSTRUCTED TO LIQUIDATE ALL SHIPMENTS OF CERTAIN PASTA FROM ITALY EXPORTED ON OR AFTER

01/01/2005 AND ON OR BEFORE 12/31/2005 AT THE FOLLOWING PERCENT OF ENTERED VALUE:

4. THE SUSPENSION OF LIQUIDATION ORDERED FOR THIS MERCHANDISE EXPORTED ON OR AFTER 01/01/2005 AND ON OR BEFORE 12/31/2005 IS LIFTED. SUSPENSION OF LIQUIDATION FOR ALL ENTRIES OF THIS MERCHANDISE EXPORTED AFTER 12/31/2005 WILL CONTINUE.
