TO THE ANTIDUMPING ORDER ON CANNED PINEAPPLE FRUIT FROM THAILAND FOR THE PERIOD 07/01/2005 THROUGH 06/30/2006.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES

HAVE BEEN REVISED FOR CERTAIN MANUFACTURERS/EXPORTERS.
THEREFORE, FOR SHIPMENTS OF CANNED PINEAPPLE FRUIT FROM THAILAND
ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR
AFTER 01/31/2008, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR
THE FOLLOWING MANUFACTURERS/ EXPORTERS:

FURTHER NOTICE. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE
INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL ASSESSMENT
INSTRUCTIONS ARE RECEIVED.
