1. ON 03/11/2008, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CHLORINATED ISOCYANURATES FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-898-001), FOR THE PERIOD 12/16/2004 THROUGH 05/31/2006.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE

NUMBER 08-00043 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED IN PARAGRAPH 3 BELOW.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE THAT (A) WERE PRODUCED OR EXPORTED BY HEBEI JIHENG CHEMICAL COMPANY, LTD.; (B) WERE REVIEWED IN THE INSTANT ADMINISTRATIVE REVIEW, THE FINAL RESULTS OF WHICH WERE PUBLISHED IN CHLORINATED ISOCYANURATES FROM THE PEOPLES REPUBLIC OF CHINA: FINAL RESULTS OF ADMINISTRATIVE REVIEW, 73 FR 159 (01/02/2008), AS AMENDED BY AMENDED FINAL RESULTS OF ANTIDUMPING DUTY ADMINISTRATIVE REVIEW: CHLORINATED ISOCYANURATES FROM THE PEOPLES REPUBLIC OF CHINA, 73 FR 9091 (02/19/2008); AND (C) WERE ENTERED OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 12/16/2004 THROUGH 05/31/2006; AND (D) REMAIN UNLIQUIDATED AS OF 5:00 P.M. ON THE FIFTH BUSINESS DAY AFTER THE DAY ON WHICH A COPY OF THIS PRELIMINARY INJUNCTION IS PERSONALLY SERVED BY PLAINTIFFS COUNSEL BY HAND. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THIS INJUNCTION HAVE NOT YET BEEN ISSUED.

5. EFFECTIVE IMMEDIATELY, CBP IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

6. THE DEPARTMENT OF COMMERCE WAS SERVED WITH THE ABOVE REFERENCED INJUNCTION ON 03/20/2008. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 03/27/2008.
