THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (73 FR 14216) ON 03/17/2008 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CERTAIN EXPORTERS SUBJECT TO THE ANTIDUMPING ORDER ON POLYETHYLENE RETAIL CARRIER BAGS FROM THE PEOPLES REPUBLIC OF CHINA FOR THE PERIOD 08/01/2005 THROUGH 07/31/2006.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES

HAVE BEEN REVISED FOR CERTAIN EXPORTERS. THEREFORE, FOR SHIPMENTS OF POLYETHYLENE RETAIL CARRIER BAGS FROM THE PEOPLE'S REPUBLIC OF CHINA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 03/17/2008, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING EXPORTERS:

RALLY PLASTICS CO., LTD. A-570-886-004 32.02%

DONGGUAN NOZAWA PLASTIC PRODUCTS CO., LTD., AND UNITED POWER PACKAGING LTD. A-570-886-002 2.58%

CHUN HING PLASTIC PACKAGING MFY LTD., AND CHUN YIP PLASTIC BAG FACTORY A-570-886-029 17.30%

3. IF ANY ENTRIES OF THIS MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE EXPORTERS LISTED ABOVE, THEN THE FOLLOWING INSTRUCTIONS APPLY:

A. IF THE PRC OR NON-PRC EXPORTER OF THE SUBJECT MERCHANDISE HAS ITS OWN RATE, USE THE APPLICABLE EXPORTER'S RATE FOR DETERMINING THE CASH DEPOSIT RATE.

B. FOR ALL PRC EXPORTERS OF SUBJECT MERCHANDISE, WHICH HAVE NOT BEEN ASSIGNED TO A SEPARATE RATE, THE CASH-DEPOSIT RATE WILL BE THE PRC-WIDE RATE OF 77.57 PERCENT.

C. FOR ALL NON-PRC EXPORTERS OF SUBJECT MERCHANDISE WHICH HAVE NOT RECEIVED THEIR OWN RATE, THE CASH-DEPOSIT RATE WILL BE THE RATE APPLICABLE TO THE PRC EXPORTER THAT SUPPLIED THAT NON-PRC EXPORTER.

4. THESE CASH DEPOSIT REQUIREMENTS SHALL REMAIN IN EFFECT UNTIL FURTHER NOTICE. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL ASSESSMENT INSTRUCTIONS ARE RECEIVED.
