IN THE ABOVE REFERENCED DETERMINATION, THE DEPARTMENT FOUND THAT ARCELOR MITTAL POINT LISAS LIMITED (A-274-804-002) IS THE SUCCESSOR IN INTEREST TO MITTAL STEEL POINT LISAS LIMITED (A-274-804-001) FOR ANTIDUMPING DUTY CASH DEPOSIT PURPOSES.

ACCORDINGLY, SHIPMENTS BY ARCELOR MITTAL POINT LISAS LIMITED OF CARBON AND CERTAIN ALLOY STEEL WIRE ROD FROM TRINIDAD AND TOBAGO SHALL RECEIVE THE SAME CASH DEPOSIT RATE AS MITTAL STEEL POINT LISAS LIMITED, FOR ALL SHIPMENTS ENTERED OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER MAY 23, 2008. EFFECTIVE MAY 23, 2008, FOR SUCH ENTRIES, U.S. CUSTOMS AND BORDER PROTECTION SHALL REQUIRE THE FOLLOWING CASH DEPOSIT RATE:
