(CONVERTIBLE CRIBS IMPORTED BY AP ARE NOT WITHIN SCOPE)

1. THE DEPARTMENT RECEIVED A SCOPE RULING REQUEST FROM AP
INDUSTRIES INC. AND LES INDUSTRIES AP INC. (AP). THE DEPARTMENT
OF COMMERCE ISSUED A FINAL SCOPE RULING ON 04/30/2008, THAT THE
CONVERTIBLE CRIBS THAT AP IMPORTS ARE NOT WITHIN THE SCOPE OF
THE ANTIDUMPING DUTY ORDER COVERING WOODEN BEDROOM FURNITURE
FROM THE PEOPLES REPUBLIC OF CHINA (A-570-890).

2. THE COMMERCE DEPARTMENT DETERMINED THAT APS CONVERTIBLE

CRIBS ARE CRIBS AS DESCRIBED IN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING WOODEN BEDROOM FURNITURE FROM THE PEOPLES REPUBLIC OF CHINA. THEREFORE, APS CONVERTIBLE CRIBS ARE NOT WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING WOODEN BEDROOM FURNITURE FROM THE PEOPLES REPUBLIC OF CHINA.

3. EFFECTIVE 04/30/2008, TERMINATE SUSPENSION AND LIQUIDATE ALL UNLIQUIDATED ENTRIES ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 06/24/2004 OF CONVERTIBLE CRIBS LISTED ABOVE.

4. REFUND ANY CASH DEPOSITS WITH INTEREST AND RELEASE ANY BONDS RELATING TO THE CONVERTIBLE CRIBS LISTED ABOVE.

5. THESE INSTRUCTIONS CONSTITUTE NOTICE OF THE LIFTING OF SUSPENSION OF LIQUIDATION OF ENTRIES OF CONVERTIBLE CRIBS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 06/24/2004.

6. THE ASSESSMENT OF ANTIDUMPING DUTIES BY CUSTOMS AND BORDER PROTECTION ON ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CBP PAY INTEREST ON OVERPAYMENTS, OR ASSESS INTEREST ON UNDER PAYMENTS, OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE PAYMENT OF ESTIMATED ANTIDUMPING DUTIES IS REQUIRED THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

7. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF WOODEN BEDROOM FURNITURE SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING WOODEN

BEDROOM FURNITURE FROM THE PEOPLES REPUBLIC OF CHINA.
