RE: SCOPE RULING FOR THE ANTIDUMPING DUTY ORDER/FINDING ON CASED PENCILS FROM CHINA (SMENCILS' NOT-YET SCENTED PENCILS ARE WITHIN THE SCOPE) (A-570-827)

1. ON AUGUST 21, 2008, IN RESPONSE TO A REQUEST BY THE SMENCIL COMPANY (SMENCILS), THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT SMENCILS' NOT-YET SCENTED PENCILS CONTAINED IN ITS HOME KIT AND MINI KIT PRODUCTS ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING CASED PENCILS FROM THE PEOPLE'S REPUBLIC OF CHINA (PRC) (A-570-827).

2. BECAUSE THE IMPORTED PRODUCT IS NOT PRODUCED FROM PAPER

INFUSED WITH SCENTS AND THUS, DOES NOT HAVE ODORS DISTINCT FROM OTHER PENCILS THAT SIMILARLY LACK AN INFUSED SCENT, SMENCILS' HOME KIT AND MINIKIT DO NOT MEET THE DESCRIPTIONS OF SCENTED PENCILS THAT ARE EXCLUDED FROM THE ORDER. THEREFORE, THE COMMERCE DEPARTMENT FOUND THIS PRODUCT TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF CASED PENCILS FROM THE PRC, INCLUDING SMENCILS' HOME KIT AND MINI KIT PENCILS LISTED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING CASED PENCILS FROM THE PRC.
