THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (73 FR 39940) ON 07/11/2008, THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CERTAIN MANUFACTURERS/EXPORTERS SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CERTAIN FROZEN WARMWATER SHRIMP FROM BRAZIL FOR THE PERIOD 02/01/2006 THROUGH 01/31/2007.

2. AS A RESULT OF THE SUCCESSOR-IN-INTEREST FINDING IN THE FINAL

RESULTS OF ADMINISTRATIVE REVIEW, COMMERCE HAS DETERMINED THAT NETUNO ALIMENTOS S.A. (A-351-838-015) IS THE SUCCESSOR-IN-INTEREST TO EMPRESA DE ARMAZENAGEM FRIGORIFICA LTDA. (EMPAF) (A-412-822-002).

3. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN MANUFACTURERS/EXPORTERS. THEREFORE, FOR SHIPMENTS OF CERTAIN FROZEN WARMWATER SHRIMP FROM BRAZIL ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 07/11/2008, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING MANUFACTURERS/EXPORTERS:

5. FOR ALL MANUFACTURERS/EXPORTERS OF CERTAIN FROZEN WARMWATER SHRIMP FROM BRAZIL WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 7.05 PERCENT.

6. THESE CASH DEPOSIT REQUIREMENTS SHALL REMAIN IN EFFECT UNTIL FURTHER NOTICE. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL ASSESSMENT INSTRUCTIONS ARE RECEIVED.
