RE: GAP PERIOD LIQUIDATION INSTRUCTIONS FOR THE ANTIDUMPING DUTY ORDER ON LIGHT-WALLED RECTANGULAR PIPE & TUBE FROM KOREA (A-580-859)

1. IN ACCORDANCE WITH SECTION 733(d) OF THE TARIFF ACT OF 1930, AS AMENDED, THE DEPARTMENT MAY SUSPEND THE LIQUIDATION OF MERCHANDISE SUBJECT TO AN ANTIDUMPING DUTY INVESTIGATION AND COLLECT ESTIMATED DUTIES FOR A TEMPORARY PERIOD (THE PROVISIONAL MEASURES PERIOD). WHEN SUBJECT MERCHANDISE CONTINUES TO BE SUSPENDED AFTER THE PROVISIONAL MEASURES PERIOD, THE DEPARTMENT MUST INSTRUCT CUSTOMS AND BORDER PROTECTION (CBP) TO TERMINATE SUSPENSION AND LIQUIDATE WITHOUT REGARD TO ANTIDUMPING DUTIES ON SUCH MERCHANDISE.

2. ON 07/28/2008, THE PROVISIONAL MEASURES PERIOD EXPIRED. HOWEVER, SUSPENSION OF LIQUIDATION OF SUBJECT MERCHANDISE MAY HAVE CONTINUED.

3. ACCORDINGLY, FOR SHIPMENTS OF LIGHT-WALLED RECTANGULAR PIPE AND TUBE FROM KOREA, ENTERED OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION THAT REMAINED SUSPENDED DURING THE PERIOD 07/29/2008 THROUGH 08/03/2008, CBP SHOULD TERMINATE THE SUSPENSION OF LIQUIDATION AND LIQUIDATE WITHOUT REGARD TO ANTIDUMPING DUTIES (I.E., RELEASE ALL BONDS AND REFUND ALL CASH DEPOSITS). INTEREST PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930 DO NOT APPLY.

4. THIS INSTRUCTION CONSTITUTES NOTICE OF THE LIFTING OF SUSPENSION OF LIQUIDATION OF ENTRIES OF SUBJECT MERCHANDISE DURING THE PERIOD 07/29/2008 THROUGH 08/03/2008.
