ON DECEMBER 2, 2008, THE INTERNATIONAL TRADE COMMISSION (ITC) PUBLISHED IN THE FEDERAL REGISTER ITS NEGATIVE FINAL DETERMINATION IN THE ANTIDUMPING DUTY INVESTIGATION OF SODIUM METAL FROM FRANCE (73 FR 73347, DECEMBER 2, 2008). THE ANTIDUMPING DUTY INVESTIGATION OF SODIUM METAL FROM FRANCE (A-427-827) HAS BEEN TERMINATED.

2. FIELD OFFICES SHOULD DISCONTINUE SUSPENSION OF LIQUIDATION OF ALL SHIPMENTS OF THIS MERCHANDISE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER MAY 28, 2008. ALL ESTIMATED ANTIDUMPING DUTIES DEPOSITED ON ENTRIES OF THE SUBJECT MERCHANDISE SHALL BE REFUNDED AND THE BONDS OR OTHER SECURITY RELEASED AT THE TIME OF LIQUIDATION.

3. NOTICE OF THE LIFTING OF SUSPENSION OF LIQUIDATION OF ENTRIES OF MERCHANDISE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER MAY 28, 2008, OCCURRED WITH THE PUBLICATION OF THE ITCS NOTICE OF NEGATIVE FINAL DETERMINATION OF INVESTIGATION (73 FR 73347, DECEMBER 2, 2008).
