1. COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (73 FR 66218) ON 11/07/2008 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CERTAIN MANUFACTURERS/EXPORTERS SUBJECT TO THE ANTIDUMPING ORDER ON CERTAIN STEEL CONCRETE REINFORCING BARS FROM TURKEY FOR THE PERIOD 04/01/2006 THROUGH 03/31/2007.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN MANUFACTURERS/EXPORTERS.

THEREFORE, FOR SHIPMENTS OF CERTAIN STEEL CONCRETE REINFORCING

4. FOR ALL MANUFACTURERS/EXPORTERS OF CERTAIN STEEL CONCRETE REINFORCING BARS FROM TURKEY WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 16.06 PERCENT.

5. THESE CASH DEPOSIT REQUIREMENTS SHALL REMAIN IN EFFECT UNTIL FURTHER NOTICE. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL ASSESSMENT INSTRUCTIONS ARE RECEIVED.
