1. ON 10/06/2008, THE U.S. COURT OF INTERNATIONAL TRADE
ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF

ORDER ON CERTAIN FROZEN WARMWATER SHRIMP FROM VIETNAM
