RE: Correction of message 3294302, dated 10/21/2013 concerning the antidumping duty order on certain frozen warmwater shrimp from the People's Republic of China ("PRC") (A-570-893)

1. This is a correction to message 3294302, dated 10/21/2013, to correct a company name listed in paragraph 3.
2. Paragraph 3 of message 3294302 contains incorrect information about the proper company name of Rizhao Smart Foods Co., Ltd. The correction message removes ("Rizhao Smart Foods") from the message. Below is the fully corrected message.

Re: Temporary Restraining Order and preliminary injunction on certain frozen warmwater shrimp from the People's Republic of China ("PRC") (A-570-893), court number 13-00346

3. On 10/16/2013 the U.S. Court of International Trade issued both a Temporary Restraining Order (TRO) and a preliminary injunction enjoining liquidation of certain entries of certain frozen warmwater shrimp from the PRC (A-570-893) for the period 02/01/2011 through 01/31/2012. On 10/21/2013, the Court issued an amended TRO and preliminary injunction to correct the information explained above in paragraph 2.
4. The TRO and preliminary injunction were issued in connection with court case number 13-00346 and enjoin liquidation of the entries described in paragraph 5 below.
5. Accordingly, until further notice, do not liquidate entries of subject merchandise which were exported by any of the following producers or exporters, and which were entered, or withdrawn from warehouse, for consumption during the period 02/01/2011 through 01/31/2012. Any entries that are set for liquidation must be unset immediately. Continue to suspend liquidation of these entries until liquidation instructions are issued:

7. Effective immediately, CBP is instructed to prevent liquidation of any entries subject to the above.

8. Commerce's APO Docket Center was served with the above-referenced TRO and injunction on 10/17/2013. Pursuant to the terms of the injunction, no liquidation of the entries covered by the injunction may be made for entries which remain unliquidated as of 5:00 p.m. of the fifth business day after which copies of this order are personally served on Commerce's APO Docket Center. Pursuant to the terms of the TRO, no liquidation of the entries covered by the temporary restraining order may be made for entries which remain unliquidated as of the date of docketing of the TRO until 5:00 p.m. on the fifth business day after which copies of the preliminary injunction are personally served on Commerce's APO Docket Center.
