2. EFFECTIVE IMMEDIATELY, CUSTOMS AND BORDER PROTECTION (CBP) SHALL DISCONTINUE THE CERTIFICATION PROGRAM WITH RESPECT TO ALL ENTRIES OF CERTAIN TISSUE PAPER PRODUCTS PRODUCED BY QUIJIANG

THAT ENTERED OR WERE WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION,
ON OR AFTER 09/05/2006.

3. UNTIL FURTHER NOTICE, CBP SHALL CONTINUE TO SUSPEND LIQUIDATION OF ANY ENTRIES OF CERTAIN TISSUE PAPER PRODUCTS PRODUCED BY QUIJIANG THAT WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION, ON OR AFTER 09/05/2006, AND REQUIRE A CASH DEPOSIT EQUAL TO THE RATE SHOWN BELOW:
