1. COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (73 FR 75397) ON 12/11/2008 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF A CERTAIN MANUFACTURER SUBJECT TO THE ANTIDUMPING ORDER ON PURIFIED CARBOXYMETHYLCELLULOSE (CMC) FROM FINLAND FOR THE PERIOD 07/01/2006 THROUGH 06/30/2007.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR A CERTAIN MANUFACTURER. THEREFORE, FOR SHIPMENTS OF PURIFIED CMC FROM FINLAND ENTERED, OR WITHDRAWN

FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 12/11/2008, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING MANUFACTURER:

4. FOR ALL MANUFACTURERS/EXPORTERS OF PURIFIED CMC FROM FINLAND WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 6.65 PERCENT.

5. THESE CASH DEPOSIT REQUIREMENTS SHALL REMAIN IN EFFECT UNTIL FURTHER NOTICE. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL ASSESSMENT INSTRUCTIONS ARE RECEIVED.
