1. THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (73 FR 75400) ON 12/11/2008 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CERTAIN MANUFACTURERS/EXPORTERS SUBJECT TO THE ANTIDUMPING ORDER ON CERTAIN PASTA FROM ITALY FOR THE PERIOD 07/01/2006 THROUGH 06/30/2007.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN MANUFACTURERS/EXPORTERS.

THEREFORE, FOR SHIPMENTS OF CERTAIN PASTA FROM ITALY ENTERED,

OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 12/11/2008, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING MANUFACTURERS/EXPORTERS:

C. WHERE NEITHER THE EXPORTER NOR THE MANUFACTURER CURRENTLY HAS ITS OWN RATE OR THE MANUFACTURER IS UNKNOWN, USE THE 'ALL OTHER' RATE FOR ESTABLISHING THE CASH DEPOSIT RATE.

4. FOR ALL MANUFACTURERS/EXPORTERS OF CERTAIN PASTA FROM ITALY

WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 15.45 PERCENT.

5. THESE CASH DEPOSIT REQUIREMENTS SHALL REMAIN IN EFFECT UNTIL FURTHER NOTICE. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL ASSESSMENT INSTRUCTIONS ARE RECEIVED.
