1. THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (73 FR 76336) ON 12/16/2008 THE FINAL RESULTS OF ADMINISTRATIVE REVIEW OF THE ANTIDUMPING ORDER ON PURE MAGNESIUM FROM THE PRC FOR THE PERIOD 5/1/2006 THROUGH 4/30/2007.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN EXPORTERS. THEREFORE, FOR SHIPMENTS OF PURE MAGNESIUM FROM THE PRC ENTERED, OR WITHDRAWN

FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 12/16/2008, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING EXPORTERS:
