STANLEY FURNITURE COMPANY, INC. (NOT WITHIN SCOPE)

1. COMMERCE RECEIVED A SCOPE RULING REQUEST FROM STANLEY  
FURNITURE COMPANY, INC (STANLEY). COMMERCE ISSUED A FINAL  
SCOPE RULING ON 12/23/2008, THAT CONVERTIBLE CRIBS THAT STANLEY  
IMPORTS ARE NOT WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER  
COVERING WOODEN BEDROOM FURNITURE FROM THE PEOPLES REPUBLIC OF  
CHINA (A-570-890).

2. COMMERCE DETERMINED THAT STANLEY'S CONVERTIBLE CRIBS ARE INFANT CRIBS WHICH ARE EXCLUDED FROM THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING WOODEN BEDROOM FURNITURE FROM THE PEOPLES REPUBLIC OF CHINA. THEREFORE, STANLEY'S CONVERTIBLE CRIBS ARE NOT WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING WOODEN BEDROOM FURNITURE FROM THE PEOPLES REPUBLIC OF CHINA.

3. EFFECTIVE 12/23/2008, TERMINATE SUSPENSION AND LIQUIDATE ALL UNLIQUIDATED ENTRIES ENTERED OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION, ON OR AFTER 01/01/2007, OF STANLEY'S CONVERTIBLE CRIBS LISTED ABOVE.

4. REFUND ANY CASH DEPOSITS WITH INTEREST AND RELEASE ANY BONDS RELATING TO STANLEY'S CONVERTIBLE CRIBS LISTED ABOVE.

5. THESE INSTRUCTIONS CONSTITUTE NOTICE OF THE LIFTING OF SUSPENSION OF LIQUIDATION OF ENTRIES OF STANLEY'S CONVERTIBLE CRIBS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 01/01/2007.

6. THE ASSESSMENT OF ANTIDUMPING DUTIES BY CBP ON SHIPMENTS OR ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CBP PAY INTEREST ON OVERPAYMENTS, OR ASSESS INTEREST ON UNDERPAYMENTS, OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE PAYMENT OF ESTIMATED ANTIDUMPING DUTIES IS REQUIRED THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

7. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF WOODEN BEDROOM FURNITURE FROM THE PEOPLES REPUBLIC OF CHINA, INCLUDING STANLEY'S WOODEN BEDROOM FURNITURE SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING WOODEN BEDROOM FURNITURE FROM THE PEOPLES REPUBLIC OF CHINA.

8.
