INDUSTRIES PUBLIC COMPANY LIMITED (A-549-817-001)

1. THE ANTIDUMPING DUTY ORDER ON CERTAIN HOT-ROLLED CARBON  
(HRC) STEEL FLAT PRODUCTS FROM THAILAND WAS REVOKED WITH  
RESPECT TO SUBJECT MERCHANDISE MANUFACTURED BY A CERTAIN  
MANUFACTURER, SAHAVIRIYA STEEL INDUSTRIES PUBLIC COMPANY  
LIMITED (SSI), EFFECTIVE 11/01/2004 (SEE 71 FR 28659; SEE ALSO  
MESSAGE NUMBER 6160214, DATED 06/09/2006). HOWEVER, COMMERCE  
HAS PUBLISHED IN THE FEDERAL REGISTER (73 FR 79809) ON  
12/30/2008 THE PRELIMINARY RESULTS OF ITS CHANGED CIRCUMSTANCES

REVIEW AND INTENT TO REINSTATE SSI IN THE ANTIDUMPING DUTY ORDER ON HRC STEEL FLAT PRODUCTS FROM THAILAND.

2. COMMERCE HAS PRELIMINARILY DETERMINED THAT SSI HAS RESUMED SELLING SUBJECT HRC STEEL FLAT PRODUCTS AT LESS THAN NORMAL VALUE CONTRARY TO THE CONDITIONS PLACED ON SSI'S ORIGINAL REVOCATION. AS A RESULT OF COMMERCE'S PRELIMINARY RESULTS, SSI (A-549-817-001) IS PRELIMINARILY REINSTATED IN THE ANTIDUMPING DUTY ORDER. ACCORDINGLY, CUSTOMS SHALL SUSPEND LIQUIDATION OF SUCH ENTRIES OF HRC STEEL FLAT PRODUCTS FROM THAILAND MANUFACTURED BY SSI, ENTERED, OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION ON OR AFTER 12/30/2008, AND REQUIRE A CASH DEPOSIT EQUAL TO THE MARGIN SHOWN BELOW:

PRODUCER: SAHAVIRIYA STEEL INDUSTRIES PUBLIC LIMITED COMPANY

CASH DEPOSIT RATE: 6.42 PERCENT

3. IF ANY ENTRIES OF THIS MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE MANUFACTURER, THEN THE FOLLOWING INSTRUCTIONS APPLY:

A. IF THE EXPORTER OF THE SUBJECT MERCHANDISE HAS ITS OWN RATE, USE THE EXPORTER'S RATE FOR DETERMINING THE CASH DEPOSIT RATE.

B. IF THE EXPORTER OF THE SUBJECT MERCHANDISE DOES NOT HAVE ITS OWN RATE, BUT THE MANUFACTURER HAS ITS OWN RATE, THE CASH DEPOSIT RATE WILL BE THE MANUFACTURER'S RATE.

C. WHERE NEITHER THE EXPORTER NOR THE MANUFACTURER CURRENTLY HAS ITS OWN RATE OR THE MANUFACTURER IS UNKNOWN, USE THE 'ALL OTHER' RATE FOR ESTABLISHING THE CASH DEPOSIT RATE.

4. FOR ALL MANUFACTURERS OR EXPORTERS OF HRC STEEL FLAT PRODUCTS FROM THAILAND WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 3.86 PERCENT.

5. THESE CASH DEPOSIT REQUIREMENTS SHALL REMAIN IN EFFECT UNTIL FURTHER NOTICE. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE INCLUDED IN THIS CHANGED CIRCUMSTANCES REVIEW UNTIL ASSESSMENT INSTRUCTIONS ARE RECEIVED.
