THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (74 FR 6571) ON 02/10/2009 THE FINAL RESULTS OF ADMINISTRATIVE REVIEW OF A CERTAIN EXPORTER SUBJECT TO THE ANTIDUMPING DUTY ORDER ON FRESHWATER CRAWFISH TAIL MEAT FROM THE PEOPLE'S REPUBLIC OF CHINA (PRC) FOR THE PERIOD 09/01/2006 THROUGH 08/31/2007.
