RE: Second Amended Temporary Restraining Order on high pressure steel cylinders from the People's Republic of China (C-570-978), court number 12-00204

1. On 09/19/2013 the U.S. Court of International Trade issued a second amended Temporary Restraining Order (TRO) enjoining liquidation of certain entries of merchandise which was produced by Beijing Tianhai Industry Co., Ltd.; or Langfang Tianhai High Pressure Container Co., Ltd.; or Tianjin Tianhai High Pressure Container Co., Ltd.; and exported by Beijing Tianhai Industry Co., Ltd.; that are subject to the countervailing duty order on high pressure steel cylinders from the People's Republic of China (C-570-978); and that were entered, or withdrawn from warehouse, for consumption on or after 10/18/2011. This second amended TRO amends message 3260308, dated 9/17/2013.
2. This TRO was issued in connection with court case number 12-00204 and enjoins liquidation of the entries described above. This TRO shall be effective for all entries which remain unliquidated as of 09/09/2013 and shall remain in effect until 5:00 p.m. on the fifth business day after which the court has ruled on plaintiff's motion for preliminary injunction.
3. Liquidation instructions for entries affected by the TRO have not yet been issued.
4. Accordingly, effective 09/09/2013 and until 5:00 p.m. on the fifth business day after which the court has ruled on plaintiff's motion for preliminary injunction, CBP is instructed not to liquidate entries of merchandise subject to the TRO as described in paragraph 1. Any entries that are set for liquidation must be unset immediately. Continue to suspend liquidation of other entries of high pressure steel cylinders from the People's Republic of China that were produced by Beijing Tianhai Industry Co., Ltd.; or Langfang Tianhai High Pressure Container Co., Ltd.; or Tianjin Tianhai High Pressure Container Co., Ltd.; and exported by Beijing Tianhai Industry Co., Ltd.; and that were entered, or withdrawn from warehouse, for consumption on or after 10/18/2011, until liquidation instructions are issued.
