RE: Antidumping duty scope determination on hand trucks and certain parts thereof from the People's Republic of China (A-570-891), MC2 Elite Magna Cart.

Notice of the lifting of suspension occurred on the message date of these instructions. See paragraph 5 below.

1. Commerce received a scope ruling request from Welcom Products. Commerce issued a final scope determination on 09/04/2013 that MC2 Elite Magna Cart which Welcom Products imports is not within the scope of the antidumping duty order on hand trucks and certain parts thereof from the People's Republic of China (A-570-891).

2. Commerce determined that MC2 Elite Magna Cart is outside the scope of the order because it is indistinguishable from the MC2 Magna Cart that had previously been ruled outside the order under the utility cart exclusion criteria. See message number 1259311 dated 09/16/2011. Therefore, the MC2 Elite Magna Cart is not within the scope of the antidumping duty order on hand trucks and certain parts thereof from the People's Republic of China.

3. For all entries of MC2 Elite Magna Cart not within scope that remain unliquidated on or after 05/24/2004, CBP shall terminate suspension and liquidate entries of product not within scope which were entered, or withdrawn from warehouse, for consumption.

4. Refund any cash deposits and release any bonds relating to MC2 Elite Magna Cart described above.

5. These instructions constitute notice of the lifting of suspension of liquidation of entries of MC2 Elite Magna Cart entered, or withdrawn from warehouse, for consumption on or after 05/24/2004.

6. The assessment of antidumping duties by CBP on shipments or entries of this merchandise is subject to the provisions of section 778 of the Tariff Act of 1930, as amended. Section 778 requires that CBP pay interest on overpayments or assess interest on underpayments of the required amounts deposited as estimated antidumping duties. The interest provisions are not applicable to cash or bonds posted as estimated antidumping duties before the date of publication

of the antidumping duty order. Interest shall be calculated from the date payment of estimated antidumping duties is required through the date of liquidation. The rate at which such interest is payable is the rate in effect under section 6621 of the Internal Revenue Code of 1954 for such period.

7. Unless instructed otherwise, for all other shipments of hand trucks and certain parts thereof from the People's Republic of China not covered by paragraph 2 above, you shall continue to collect cash deposits of estimated antidumping duties for the merchandise at the current rates.
