ON 03/04/2009, IN RESPONSE TO A REQUEST BY ARMEL ENTERPRISES, INC., COMMERCE ISSUED A FINAL SCOPE RULING THAT THE FOUR IMPORTED CHESTS FROM ARMELS CHILDREN PLAYROOM AND ACCENT FURNITURE (I.E., MODEL 31912, MODEL 36913, MODEL 34791, AND MODEL 24111) ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING WOODEN BEDROOM FURNITURE FROM THE PRC (A-570-890).

2. BECAUSE THE IMPORTED PRODUCTS MEET THE DESCRIPTION OF CHESTS

UNDER THE ORDER, THE COMMERCE DEPARTMENT FOUND THESE PRODUCTS
TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF WOODEN BEDROOM
FURNITURE FROM THE PRC, INCLUDING THE FOUR IMPORTED CHESTS FROM
ARMELS CHILDREN PLAYROOM AND ACCENT FURNITURE (I.E. MODEL
31912, MODEL 36913, MODEL 34791, AND MODEL 24111) LISTED ABOVE,
SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING WOODEN BEDROOM
FURNITURE FROM THE PRC.
