RE: SCOPE RULING ON ANTIDUMPING DUTY ORDER ON CERTAIN LINED PAPER PRODUCTS FROM CHINA (A-570-901); LAKESHORE PRODUCTS: RR630, RR631, GG181 & 182, GG185 & 186.

1. ON 03/04/2009, IN RESPONSE TO A REQUEST BY LAKESHORE LEARNING MATERIALS (LAKESHORE), COMMERCE ISSUED A FINAL SCOPE RULING THAT LAKESHORES RR630 AND RR631 (DRAW & WRITE JOURNAL), GG181 AND GG182 (THE WRITERS NOTEBOOK) AND GG185 AND GG186 (READERS RESPONSE NOTEBOOK), COLLECTIVELY LAKESHORES WRITING JOURNALS ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING CERTAIN LINED PAPER PRODUCTS ("CLPP") FROM THE PEOPLES REPUBLIC OF CHINA ("PRC") A-570-901.

2. BECAUSE THE IMPORTED PRODUCTS (I.E. LAKESHORE'S WRITING JOURNALS) HAVE SIMILAR PHYSICAL CHARACTERISTICS, ULTIMATE USES AND THERE ARE SIMILAR EXPECTATIONS OF ULTIMATE PURCHASERS AS CLPP SUBJECT TO THE SCOPE OF THE ORDER, THE COMMERCE DEPARTMENT FOUND THESE PRODUCTS TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF CLPP FROM THE PRC INCLUDING LAKESHORE'S WRITING JOURNALS LISTED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING CLPP FROM THE PRC.
