RE: PRELIMINARY INJUNCTION ON LOW ENRICHED URANIUM FROM FRANCE (A-427-818) (CT. NO. 04-00426); MANUF/EXP BY EURODIF/AREVA; EXCLUDE 01/09/02 THROUGH 02/12/02

1. ON 04/30/2004, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON LOW ENRICHED URANIUM FROM FRANCE (A-427-818), MANUFACTURED OR EXPORTED BY EURODIF S.A. AND AREVA (FORMERLY COMPAGNIE GENERALE DES MATIERES NUCLEAIRES)(EURODIF/AREVA)FOR THE PERIOD (A) ON OR AFTER JULY 13, 2001 THROUGH JANUARY 8, 2002, OR (B) ON OR AFTER FEBRUARY 13, 2002 THROUGH JANUARY 31, 2003.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 04-00426 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED IN PARAGRAPH #3 BELOW.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE PRODUCED OR EXPORTED BY EURODIF/AREVA AND WHICH WERE ENTERED OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION DURING THE PERIODS:

(A) ON OR AFTER JULY 13, 2001 THROUGH JANUARY 8, 2002;

OR

(B) ON OR AFTER FEBRUARY 13, 2002 THROUGH JANUARY 31, 2003.

CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL THE INJUNCTION IS LIFTED AND LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THIS INJUNCTION HAVE NOT YET BEEN ISSUED. LIQUIDATION OF THESE ENTRIES WAS PREVIOUSLY ENJOINED BY AN EARLIER INJUNCTION

COVERING CERTAIN ENTRIES FOR THE PERIOD (A) JULY 13, 2001 THROUGH JANUARY 8, 2002 OR (B) ON OR AFTER FEBRUARY 13, 2002. SEE MESSAGE NO. 3168201, DATED 06/17/2003. THE COURT HAS ALSO ISSUED SEPARATE INJUNCTIONS COVERING CERTAIN ENTRIES FOR THE PERIOD FEBRUARY 1, 2003 THROUGH JANUARY 31, 2004 AND FEBRUARY 1, 2004 THROUGH JANUARY 31, 2005. SEE MESSAGE NO. 6027214, DATED 01/27/2006, AND MESSAGE NO. 9065203, DATED 03/06/2009. THOSE INJUNCTIONS REMAIN IN PLACE, CONCURRENTLY, UNTIL LIFTED.

5. EFFECTIVE IMMEDIATELY, U.S. CUSTOMS AND BORDER PROTECTION (CBP) IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

6. THE DEPARTMENT OF COMMERCE WAS SERVED WITH THE ABOVE REFERENCED INJUNCTION ON 02/13/2009. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS

OF 5:00 PM ON THE FIFTH BUSINESS DAY AFTER THE DAY ON WHICH COPIES OF THE ORDER ARE PERSONALLY SERVED ON COMMERCE'S APO DOCKET CENTER.
