RE: LIQUIDATION ORDERS FOR ANTIDUMPING SCOPE RULING ON CERTAIN LINED PAPER PRODUCTS FROM CHINA (A-570-901); LAKESHORE PRODUCTS: RR, AA, AND GG SERIES

1. COMMERCE RECEIVED A SCOPE RULING REQUEST FROM LAKESHORE LEARNING MATERIALS (LAKESHORE). THE DEPARTMENT ISSUED A FINAL SCOPE RULING ON 03/04/2009, THAT LAKESHORE'S RR973 AND RR974 (READERS BOOK LOG), AA786 AND AA787 (MY FIRST DRAW & WRITE JOURNAL) RR673 AND RR674 (MY WORD JOURNAL), AA185 AND AA186 (MI DIARIO DE PALABRAS), AA181 AND AA182 (MY PICTURE WORD JOURNAL) AND GG324 AND GG325 (WRITING PROMPTS JOURNAL), COLLECTIVELY KNOWN AS EXERCISE BOOKS ARE NOT WITHIN THE SCOPE

OF THE ANTIDUMPING DUTY ORDER COVERING CERTAIN LINED PAPER PRODUCTS (CLPP) FROM THE PEOPLE'S REPUBLIC OF CHINA (PRC) (A-570-901).

2. COMMERCE DETERMINED THAT LAKESHORE'S EXERCISE BOOKS:

- (1) ARE PHYSICALLY DIFFERENT FROM MERCHANDISE SUBJECT TO THE SCOPE OF THE ORDER ON CLPP FROM THE PRC;
- (2) HAVE A DIFFERENT ULTIMATE USE AND THERE ARE DIFFERENT EXPECTATIONS BY THE PURCHASER OF CLPP COVERED BY THE SCOPE OF THE ORDER;
- (3) ARE SOLD THROUGH SPECIALIZED CHANNELS OF TRADE THAT ARE NOT WIDELY USED FOR SELLING MERCHANDISE SUBJECT TO THE SCOPE OF THE ORDER ON CLPP FROM THE PRC; AND,
- (4) ARE ADVERTISED AND DISPLAYED DIFFERENTLY FROM MERCHANDISE SUBJECT TO THE SCOPE OF THE ORDER ON CLPP FROM THE PRC.

THEREFORE, LAKESHORE'S EXERCISE BOOKS, LISTED ABOVE, ARE NOT WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING CLPP FROM THE PRC.

3. EFFECTIVE 04/17/2006, TERMINATE SUSPENSION AND LIQUIDATE ALL UNLIQUIDATED ENTRIES ENTERED, OR WITHDRAWN FROM WAREHOUSE OF LAKESHORE'S EXERCISE BOOKS LISTED ABOVE.

4. REFUND ANY CASH DEPOSITS WITH INTEREST AND RELEASE ANY BONDS RELATING TO LAKESHORES EXERCISE BOOKS LISTED ABOVE.

5. THESE INSTRUCTIONS CONSTITUTE NOTICE OF THE LIFTING OF SUSPENSION OF LIQUIDATION OF ENTRIES OF LAKESHORE'S RR973 AND RR974 (READERS BOOK LOG), AA786 AND AA787 (MY FIRST DRAW & WRITE JOURNAL) RR673 AND RR674 (MY WORD JOURNAL), AA185 AND AA186 (MI DIARIO DE PALABRAS), AA181 AND AA182 (MY PICTURE WORD JOURNAL) AND GG324 AND GG325 (WRITING PROMPTS JOURNAL) ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 04/17/2006.

6. THE ASSESSMENT OF ANTIDUMPING DUTIES BY CBP ON SHIPMENTS OR ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CBP PAY INTEREST ON OVERPAYMENTS, OR ASSESS INTEREST ON UNDERPAYMENTS, OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES.

THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE PAYMENT OF ESTIMATED ANTIDUMPING DUTIES IS REQUIRED THROUGH THE DATE OF LIQUIDATION.

THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

7. FOR ALL OTHER SHIPMENTS OF CLPP FROM THE PRC NOT COVERED BY PARAGRAPH #2 ABOVE, YOU SHALL, UNLESS OTHERWISE INSTRUCTED, CONTINUE TO COLLECT CASH DEPOSITS OF ESTIMATED ANTIDUMPING DUTIES FOR THE MERCHANDISE AT THE CURRENT RATES.

8.
