1. ON MAY 4, 2009, IN RESPONSE TO A REQUEST BY ZNP CREATIVE COMPANY LIMITED, THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT THE 5 MINUTE CANDLE IS WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-504).

2. BECAUSE THE IMPORTED PRODUCT IS IN A SHAPE THAT IS SPECIFICALLY ENUMERATED IN THE SCOPE OF THE ORDER, THE COMMERCE DEPARTMENT FOUND THIS PRODUCT TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA, INCLUDING ZNP CREATIVE COMPANY LIMITEDS 5 MINUTE CANDLE LISTED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING PETROLUEM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA.
