THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (74 FR 23682) ON 05/20/2009 THE FINAL RESULTS OF ADMINISTRATIVE REVIEW OF A CERTAIN EXPORTER SUBJECT TO THE ANTIDUMPING ORDER ON REFINED BROWN ALUMINUM OXIDE FROM THE PEOPLE'S REPUBLIC OF CHINA (PRC) FOR THE PERIOD 11/01/2006 THROUGH 10/31/2007.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATE HAS BEEN REVISED FOR A CERTAIN EXPORTER. THEREFORE, FOR SHIPMENTS

OF REFINED BROWN ALUMIMUM OXIDE FROM THE PRC ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 05/20/2009, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING EXPORTER:

4. THESE CASH-DEPOSIT REQUIREMENTS SHALL REMAIN IN EFFECT UNTIL FURTHER NOTICE. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL ASSESSMENT INSTRUCTIONS ARE RECEIVED.
