1. COMMERCE RECEIVED A SCOPE RULING REQUEST FROM BIOLAB INC.
COMMERCE ISSUED A FINAL SCOPE RULING ON 03/23/2009, THAT
CHLORINATED ISOCYANURATES PRODUCED AND EXPORTED FROM VIETNAM
BY TIAN HUA (VIETNAM) SPC INDUSTRIES LTD., ARE NOT WITHIN THE
SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING CHLORINATED
ISOCYANURATES FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-898).

2. COMMERCE DETERMINED THAT TIAN HUA (VIETNAM) SPC INDUSTRIES

LTD.'S CHLORINATED ISOCYANURATES PRODUCED IN VIETNAM AND EXPORTED FROM VIETNAM ARE NOT WITHIN THE SCOPE OF THE ORDER BECAUSE THEY WERE PRODUCED IN VIETNAM, NOT THE PEOPLE'S REPUBLIC OF CHINA. THEREFORE, TIAN HUA (VIETNAM) SPC INDUSTRIES LTD.'S CHLORINATED ISOCYANURATES THAT ARE PRODUCED AND EXPORTED FROM

VIETNAM ARE NOT WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING CHLORINATED ISOCYANURATES FROM THE PEOPLE'S REPUBLIC OF CHINA.

3. FOR ALL OTHER SHIPMENTS OF CHLORINATED ISOCYANURATES FROM THE PEOPLES REPUBLIC OF CHINA NOT COVERED BY PARAGRAPH #2 ABOVE, YOU SHALL, UNLESS OTHERWISE INSTRUCTED, CONTINUE TO COLLECT CASH DEPOSITS OF ESTIMATED ANTIDUMPING DUTIES FOR THE MERCHANDISE AT THE CURRENT RATES.
