RE: SCOPE RULING: HAND TRUCKS & PARTS THEREOF FROM CHINA (PRC) (A-570-891) SAMSONITE MICRO MOVER FOLD-AWAY CARRY -ON CART & AMERICAN TOURISTER SWING WHEEL LUGGAGE CART

1. ON 06/03/2009, IN RESPONSE TO A REQUEST BY E&B GIFTWARE, LLC (E&B GIFTWARE), COMMERCE ISSUED A FINAL SCOPE RULING THAT THE SAMSONITE MICRO MOVER FOLD-AWAY CARRY-ON CART AND THE AMERICAN TOURISTER SWING WHEEL LUGGAGE CART ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING HAND TRUCKS AND CERTAIN PARTS THEREOF FROM THE PRC (A-570-891).

2. BECAUSE BOTH IMPORTED PRODUCTS ARE HAND TRUCKS WHICH

INCORPORATE A "HORIZONTAL PROJECTING EDGE, OR TOE PLATE, PERPENDICULAR OR ANGLED TO THE VERTICAL FRAME, AT OR NEAR THE LOWER SECTION OF THE VERTICAL FRAME", AND ARE CAPABLE OF SLIDING UNDER A LOAD THAT IS SLIGHTLY TIPPED, THE COMMERCE DEPARTMENT FOUND THESE PRODUCTS TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF HAND TRUCKS AND CERTAIN PARTS THEREOF FROM THE PRC, INCLUDING E&B GIFTWARE'S SAMSONITE MICRO MOVER FOLD-AWAY CARRY-ON CART AND AMERICAN TOURISTER SWING WHEEL LUGGAGE CART LISTED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING HAND TRUCKS AND CERTAIN PARTS THEREOF FROM THE PRC.
