COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (74 FR 19046) ON 04/27/2009 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF A CERTAIN MANUFACTURER/EXPORTER SUBJECT TO THE ANTIDUMPING ORDER ON CERTAIN CUT-TO-LENGTH CARBON-QUALITY STEEL PLATE PRODUCTS (CTL PLATE) FROM THE REPUBLIC OF KOREA (KOREA) FOR THE PERIOD 02/01/2007 THROUGH 01/31/2008.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATE HAS

BEEN REVISED FOR A CERTAIN MANUFACTURER/EXPORTER. THEREFORE, FOR SHIPMENTS OF CTL PLATE FROM KOREA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 04/27/2009, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING MANUFACTURER/EXPORTER:

4. FOR ALL MANUFACTURERS/EXPORTERS OF CTL PLATE FROM KOREA WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 0.98 PERCENT.

5. THESE CASH DEPOSIT REQUIREMENTS SHALL REMAIN IN EFFECT UNTIL FURTHER NOTICE. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL ASSESSMENT INSTRUCTIONS ARE RECEIVED.
