1. COMMERCE RECEIVED A SCOPE RULING REQUEST FROM TARGET CORPORATION. COMMERCE ISSUED A FINAL SCOPE RULING ON 4/15/09 THAT TARGET CORPORATIONS SIMPLY SHABBY CHIC SECRETARY MIRROR IS NOT WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING WOODEN BEDROOM FURNITURE FROM THE PEOPLES REPUBLIC OF CHINA (A-570-890).

2. COMMERCE DETERMINED THAT TARGET CORPORATIONS SIMPLY SHABBY CHIC SECRETARY MIRROR IS NOT A PIECE OF WOODEN BEDROOM

FURNITURE BECAUSE IT DOES NOT ATTACH TO, INCORPORATE IN, SIT ON, OR HANG OVER A DRESSER AND IS NOT DESIGNED AND MARKETED TO BE SOLD IN CONJUNCTION WITH A DRESSER AS PART OF A DRESSER-MIRROR SET. THEREFORE, TARGET CORPORATIONS SIMPLY SHABBY CHIC SECRETARY MIRROR IS NOT WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING WOODEN BEDROOM FURNITURE FROM THE PEOPLES REPUBLIC OF CHINA.

3. EFFECTIVE 01/01/2007, TERMINATE SUSPENSION AND LIQUIDATE ALL UNLIQUIDATED ENTRIES ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 01/01/2007, OF THE SIMPLY SHABBY CHIC SECRETARY MIRROR LISTED ABOVE.

4. REFUND ANY CASH DEPOSITS WITH INTEREST AND RELEASE ANY BONDS RELATING TO THE SIMPLY SHABBY CHIC SECRETARY MIRROR LISTED ABOVE.

5. THESE INSTRUCTIONS CONSTITUTE NOTICE OF THE LIFTING OF SUSPENSION OF LIQUIDATION OF ENTRIES OF THE SIMPLY SHABBY CHIC SECRETARY MIRROR ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 01/01/2007.

6. THE ASSESSMENT OF ANTIDUMPING DUTIES BY CBP ON SHIPMENTS OR ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CBP PAY INTEREST ON OVERPAYMENTS, OR ASSESS INTEREST ON UNDERPAYMENTS, OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE PAYMENT OF ESTIMATED ANTIDUMPING DUTIES IS REQUIRED THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

7. FOR ALL OTHER SHIPMENTS OF WOODEN BEDROOM FURNITURE FROM THE PEOPLES REPUBLIC OF CHINA NOT COVERED BY PARAGRAPH # 2 ABOVE, YOU SHALL, UNLESS OTHERWISE INSTRUCTED, CONTINUE TO COLLECT CASH DEPOSITS OF ESTIMATED ANTIDUMPING DUTIES FOR THE MERCHANDISE AT THE CURRENT RATES.
