1. COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (74 FR 33995) ON 07/14/2009, THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF ONE MANUFACTURER/EXPORTER SUBJECT TO THE ANTIDUMPING DUTY ORDER

ON STAINLESS STEEL BAR FROM BRAZIL FOR THE PERIOD 02/01/2007 THROUGH 01/31/2008.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATE HAS BEEN REVISED FOR A CERTAIN MANUFACTURER/EXPORTER. THEREFORE,

FOR SHIPMENTS OF STAINLESS STEEL BAR FROM BRAZIL ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 07/14/2009, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING MANUFACTURER/EXPORTER:

VILLARES METALS S.A.

3. IF ANY ENTRIES OF MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE MANUFACTURER, THEN THE FOLLOWING INSTRUCTIONS APPLY:

3. FOR ALL MANUFACTURERS/EXPORTERS OF STAINLESS STEEL BAR FROM BRAZIL WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 19.43 PERCENT.

4. THESE CASH DEPOSIT REQUIREMENTS SHALL REMAIN IN EFFECT UNTIL FURTHER NOTICE. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL ASSESSMENT INSTRUCTIONS ARE RECEIVED.
