1. ON 06/23/2009, THE U.S. COURT OF INTERNATIONAL TRADE
ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF
CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY
ORDER ON LINED PAPER PRODUCTS FROM INDIA A-533-843, FOR THE
PERIOD 04/17/2006 THROUGH 08/31/2007.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 09-00200 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED IN PARAGRAPH #3 BELOW.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH:

- ARE TYPICALLY IMPORTED UNDER HEADINGS 4820.10.2050, 4810.22.5044, 4811.90.9090, 4820.10.2010, 4820.10.2020 OF THE HARMONIZED TARIFF SCHEDULE OF THE UNITED STATES (HTSUS). THE

HTSUS HEADINGS ARE PROVIDED FOR CONVEIENCE AND CUSTOMS PURPOSES; HOWEVER, THE WRITTEN DESCRIPTION OF THE SCOPE OF THE ORDER IS DISPOSITIVE.

ANY ENTRIES THAT ARE SET FOR LIQUIDATION MUST BE UNSET IMMEDIATELY. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. THIS INJUNCTION APPLIES TO ENTRIES COVERED BY THE LIQUIDATION INSTRUCTIONS MESSAGE NUMBER 9167201, DATE 06/16/2009.

5. EFFECTIVE IMMEDIATELY, CBP IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.
