1. COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (74 FR 33406) ON 07/13/2009 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CERTAIN EXPORTERS SUBJECT TO THE ANTIDUMPING ORDER ON CERTAIN CASED PENCILS FROM THE PEOPLE'S REPUBLIC OF CHINA FOR THE PERIOD 12/01/2006 THROUGH 11/30/2007.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN EXPORTERS. THEREFORE, FOR SHIPMENTS OF CERTAIN CASED PENCILS FROM THE PEOPLE'S REPUBLIC

3. IF ANY ENTRIES OF THIS MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE EXPORTERS LISTED ABOVE, THEN THE FOLLOWING INSTRUCTIONS APPLY:

A. IF THE PRC OR NON-PRC EXPORTER OF THE SUBJECT MERCHANDISE HAS ITS OWN RATE, USE THE APPLICABLE EXPORTER'S RATE FOR DETERMINING THE CASH DEPOSIT RATE.

B. FOR ALL PRC EXPORTERS OF SUBJECT MERCHANDISE, WHICH HAVE NOT BEEN ASSIGNED TO A SEPARATE RATE, THE CASH-DEPOSIT RATE WILL BE THE PRC-WIDE RATE OF 114.90 PERCENT.

4. THESE CASH DEPOSIT REQUIREMENTS SHALL REMAIN IN EFFECT UNTIL FURTHER NOTICE. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL ASSESSMENT INSTRUCTIONS ARE RECEIVED.
