1. ON 07/13/2009, IN RESPONSE TO A REQUEST BY DIRECT
INNOVATIONS, COMMERCE ISSUED A FINAL SCOPE RULING THAT
DECORATIVE RETAIL MAGNETS ARE WITHIN THE SCOPE OF THE
ANTIDUMPING ORDER COVERING RAW FLEXIBLE MAGNETS FROM THE
PEOPLE'S REPUBLIC OF CHINA (A-570-922).

2. BECAUSE THE IMPORTED DECORATIVE RETAIL MAGNETS IN QUESTION
ARE COVERED BY THE LANGUAGE OF THE SCOPE THAT REFERS TO SUBJECT
MAGNETS BEING BONDED WITH PAPER, PLASTIC, OR OTHER MATERIAL, OF

ANY COMPOSITION AND/OR COLOR AND BECAUSE THE DECORATIVE RETAIL MAGNETS AT ISSUE DO NOT INCORPORATE A MATERIAL THAT BEARS PRINTED TEXT AND/OR IMAGES IN A MANNER THAT MEETS THE EXCLUSION CRITERIA FOR PRINTED FLEXIBLE MAGNETS, COMMERCE FOUND THE DECORATIVE RETAIL MAGNETS AT ISSUE TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF RAW FLEXIBLE MAGNETS FROM THE PEOPLE'S REPUBLIC OF CHINA, INCLUDING DIRECT INNOVATION'S DECORATIVE RETAIL MAGNETS DISCUSSED ABOVE, SUBJECT TO THE ANTIDUMPING ORDER COVERING RAW FLEXIBLE MAGNETS FROM CHINA.
