ON 08/05/2008, COMMERCE PUBLISHED IN THE FEDERAL REGISTER (73 FR 45403) ITS ANTIDUMPING DUTY ORDER AND AMENDED FINAL DETERMINATION IN THE ANTIDUMPING INVESTIGATION OF LIGHT-WALLED RECTANGULAR PIPE AND TUBE FROM KOREA (A-580-859-000 THROUGH -013). THIS IS A CORRECTION OF PARAGRAPH 4 IN MESSAGE NUMBER 8246206, DATED 09/02/2008.

2. IN PARAGRAPH 4 OF MESSAGE NUMBER 8246206, THE DEPARTMENT INCORRECTLY STATED THE CASH DEPOSIT REQUIREMENTS FOR
