RE: SCOPE RULING ON COUNTERVAILING DUTY ORDER ON FRESH AND CHILLED ATLANTIC SALMON FROM NORWAY (C-403-802)

1. ON 08/05/2009, IN RESPONSE TO A REQUEST BY CHANGING SEAS, COMMERCE ISSUED A FINAL SCOPE RULING THAT WHOLE SALMON STEAKS AND WHOLE SALMON ROASTS ARE WITHIN THE SCOPE OF THE COUNTERVAILING DUTY ORDER COVERING FRESH AND CHILLED ATLANTIC SALMON FROM NORWAY (C-403-802).

2. BECAUSE THE IMPORTED WHOLE SALMON STEAKS AND WHOLE SALMON ROASTS AT ISSUE ARE NOT DISTINCT FROM FRESH AND CHILLED ATLANTIC SALMON COVERED UNDER THE SCOPE OF THE ANTIDUMPING AND

COUNTERVAILING DUTY ORDERS IN TERMS OF PHYSICAL CHARACTERISTICS, EXPECTATIONS OF THE ULTIMATE PURCHASERS, ULTIMATE USE OF THE PRODUCT, CHANNELS OF TRADE IN WHICH THE PRODUCT IS SOLD, AND THE MANNER IN WHICH THE PRODUCT IS ADVERTISED AND DISPLAYED, COMMERCE FOUND WHOLE SALMON STEAKS AND WHOLE SALMON ROASTS TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF FRESH AND CHILLED ATLANTIC SALMON FROM NORWAY, INCLUDING CHANGING SEAS' WHOLE SALMON STEAKS AND WHOLE SALMON ROASTS DISCUSSED ABOVE, SUBJECT TO THE COUNTERVAILING DUTY ORDER COVERING FRESH AND CHILLED ATLANTIC SALMON FROM NORWAY.
